The Healthy Greater Christchurch Advisory Group met on 22 May 2019.

## Key points from the meeting

• Following the 15-March mosque attacks, several signatories proposed an extended lunchtime seminar on the subject of 'Being Unbreakable'—time and space to gather, share, and reflect—and for some, to consider what we could do next—together. Waka Toa Ora held the seminar just over six weeks after the mosque attacks. Several actions were identifies and a follow-up seminar was suggested for the future.

<u>A shared Google Document has been updated to include what was discussed</u>. A follow-up session was suggested; this will be considered in the coming months.

- Website review is under way to reflect announcement of the new name and logo at the hui.
- The Advisory Group is working collaboratively to deliver a submissions workshop later this year.
- ECan has declared a 'climate emergency' and CCC may soon follow suit [note since the meeting, this has taken place]; this prompted Waka Toa Ora to identify its role discussion to be continued and include signatories.
- Report on Waka Toa Ora being sent to the Greater Christchurch Partnership.

## Waka Toa Ora

The <u>Greater Christchurch Partnership</u> identified Healthy Christchurch as a lead for the 'Health & Communities' stream of the <u>Urban Development Strategy</u>, along with the Selwyn and Waimakariri District Councils. A working group convened and decided to formally expand Healthy Christchurch across the region and to adopt a more geographically inclusive name—Waka Toa Ora.

The group has developed a high-level work programme and will continue to engage with signatories as this progresses. The initiative will continue to lead new projects, be a vehicle for communication and consultation with communities, and provide a mechanism to be voice at decision making tables around the region.
